Local Plan Update Serious concerns remain about flooding and over-development

On 6th June councillors voted to pause the inspection of the Local Plan to allow time to get new members up to speed and review its implications.

The existing Plan requires more than 9,000 homes to be built in the next 15 years. To achieve this, the Plan includes over 5,000 units to be built in Staines and more than 800 from Green Belt sites across the Borough. In comparison, Elmbridge has recently submitted a Plan that meets only 70% of their assessed target, with no release of Green Belt.

During the pause, briefings were given by Council officers and there was a review by an external expert to look for possible improvements to the Plan. The need for more of a "Vision" for Spelthorne was highlighted, and a former government Chief Architect gave suggestions on how Design Codes should be used to shape developments and protect the character of areas.

Many other councils have either paused or withdrawn their plans following the policy changes announced by Michael Gove in December 2022.

In a letter to local authorities, Michael Gove said that "local planning authorities are not expected to review the Green Belt". He also said that "It will be up to local authorities, working with their

communities, to determine how many homes can actually be built".

In September Spelthorne councillors voted to continue the pause until the new government planning framework is finalised and there is clarity on policy.

The Planning Inspectorate was advised of the decision and in reply stated that before the examination can continue some outstanding issues "in particular flood risk" must be addressed. The Council has not yet been able to satisfy the Environment Agency (ÉA) that the allocated housing sites are an acceptable flood risk

The latest information received from the EA suggests that several sites in Staines are not suitable for development because of flood risk and this could mean that the Plan cannot proceed in its current form.

Vehicles regularly speed along Lower Sunbury and Halliford roads, not only on major roads but also on many side roads.

Speed limits and control measures are not consistent across Lower Sunbury. The existing limits are regularly ignored, and the signage is nothing like as clear as in Richmond, where there is much wider use of 20 mph limits and clear signs and road markings.

Surrey County Council is considering implementing 20mph limits on residential roads, as Wales has done as a national standard.



Residents have been contacting us over the future of the London Irish site since the professional club went into administration in June. Your local councillors have been working through Spelthorne Borough Council to support the Hazlewood Centre and ensure the continuation of amateur sporting activities.

The whole site is designated as Green Belt and there are legal agreements that limit the usage to sport. We shall be making sure that any new owner knows and observes these requirements.

Bugle planning application

South Western Railways are planning to reduce station staffing and and close ticket offices. Lib Dems are concerned that this will mean that anyone with problems using automatic ticket machines will be put off using rail transport.

Spelthorne Lib Dems are opposed to these closures and have responded to the consultation.

We want cleaner water

The national sewage scandal (Focus Spring 2023) continues unabated – with the Conservative government repeatedly failing to to take action against water company breaches.

On 13th September, Lib Dems voted with other opposition parties in the House of Lords to support a Green motion and successfully defeated a government bid to weaken developer's responsibilities for protecting water supplies.

Clean water should be a cross-party priority but the Conservatives just don't care. See our website for more on Lib Dem environment policies.



In July 2021 permission was granted to build 31 homes on part of the Bugle Nuseries site after an appeal by the applicant. In November last year a further application was submitted to **increase this to 80 homes**, using more of the Green Belt land.

Planning decisions are meant to be made with 13 weeks of receipt of a valid application, unless an extension is agreed. The applicant has decided to appeal to the Planning Inspectorate rather than wait for a decision from Spelthorne. In August Spelthorne Planning Committee confirmed that they did not regard the application as acceptable.

Councillor Sandra Dunn commented "the Council will strongly oppose the granting of permission at the Appeal, which is scheduled for the end of November."
